BEST FAIR IN HISTORY OF COUNTY

FINEST EXHIBITS AND BEST LINE OF RACING STOCK EVER ASSEMBLED IN SOUTHERN IDAHO GREETS THE VISITORS AT FILER.

FILER, Sept. 8.—Order came out of county today at the county fair ground and in the pavilions that there was no place of apparent confusion in pavilions, as one exhibit after another took shape in what is the biggest and best fair ever held for the visitors of the hundred-painted claim exhibit in the Women's pavilion and the display of canned fruits and jellies in the same were the best ever seen in the state and, in these cases, judgment on the exhibits had already been passed.

YOUNG SLAYER MAY NEVER BE GIVEN HEARING

New Jersey Youth Who Confessed to Killing Girl and Chauffeur to Be Examined by Lunacy Commission.

NEWARK, N. J., Sept. 8.—Harrison Noel probably never will be brought to trial for the killing of his chauffeur, the police announced yesterday, as the prosecution has decided the way for his examination by a lunacy commission.

The 20-year-old kid glove killer was the subject of state inquiry. The youth, son of a prominent New York lawyer, had been accused of killing his chauffeur, whose body was found near the Atlantic Ocean highway in New York and the Craigatorium at Beacon, N. Y.





