PIRATES WIN AGAIN TODAY AND EVEN SERIES

D. F. DAVIS IS NEW WAR SECRETARY

Appointment of St. Louis Man, Former Acting Secretary, Is Made Simultaneously With Formal Announcement of John W. Weeks' Resignation Because of Ill Health; Latter Will Retire at Once to Private Life in His Massachusetts Home.

WASHINGTON, Oct. 13.— Dwight Davis of St. Louis, Mo., today was named secretary of war by President Coolidge, who also made simultaneous announcement of the long anticipated resignation of Secretary John Weeks, because of ill health.

The resignation and appointment were made public without any loving Weeks' audience at his final cabinet meeting this morning.

Weeks is expected to retire at once to his life of quiet after his cabinet, under two previous presidents, he had not been able to work since April 1, when he was attacked by paralysis, and his health has been practically certain since that time.

Official announcement, however, has been withheld by President Coolidge until he was able to decide on an successor. Davis, 47, a former member of Congress, with the rank of colonel in the officers' reserve corps, received the appointment because of his administrative ability. He was in the department during Weeks' absence. His defense of the president's economic program against the drive of the general strike was particularly well-gained for him the president's favor.

Davis was appointed director of the war's air arm by Gen. Billy Mitchell in 1921 and retained that position until 1922 when he became assistant secretary of war, succeeding J. Nathan Wadsworth of New York, elected to Congress.

He is perhaps best known as donor of the Davis cup, the international tennis trophy. He was a nationally known boxer in his youth. He is 46 years old.

Davis can be expected, as secretary of war, to continue his support of the war's air arm, which he helped establish in 1921 and retained that position until 1922 when he became assistant secretary of war, succeeding J. Nathan Wadsworth of New York, elected to Congress.

The new secretary gained wide approval in administration circles, it was said, because he had been retained by the president in the imperial civilian aviation inquiry, now in progress, as a way out of the aircraft controversy.

Weeks' retirement, N. H., 65 years ago, the high point of his career, was in the republican national convention in 1912 when he ran second to Charles Evans Hughes for the presidential nomination.

Weeks was President Harding's original choice for secretary of war, and President Coolidge retained him in his cabinet.

He was regarded as a right adviser to both republicans and democrats in their legislative activities.

He was appointed to the United States naval academy at Annapolis and graduated in 1881. He was a captain in the U. S. Cavalry and commissioner of the Florida Southern railroad for six years. He returned from Florida to Boston and continued his law practice in 1890. In 1896 he was elected to congress in 1906 and as lieutenant to Murray Crane, was one of the state's republican leaders.

WAGE POLICY IS AVERTED

ATLANTIC CITY, Oct. 13.—An epochal step in the formation of a new wage policy has been definitely taken by the American Federation of Labor. By burying—once more as a committee a proposal that the federal government define a policy of wage regulation, the A. F. L. has increased and the working day shortened, in the degree that labor-saving machinery tends to increase production. The annual convention of the grain dealers' national association here today pointed out that there should be no intermingling of public service in which there should be no intermingling of politics and economics.

“But we have solved the friendly aid we have been giving the whole problem of grain marketing,” he said.

A HARD LESSON BUT THOROUGH

Two young men of Idaho have received penitentiary sentences recently on the charge of involuntary manslaughter. The people who have been the victims are just as dead as though the killing had been through wilful and deliberate murder, though the penalty inflicted on those responsible has not been so great.

Both prison sentences were the result of avoidable automobile accidents on the public highway: Accidents the result of carelessness and neglect which resulted in death for one and the stain of a prison sentence on the other.

The way seems hard. It is hard to sentence anyone to the state penitentiary, but is there any other way out of it?

Deaths by automobile accidents have mounted to the point where it has become a positive menace. Auto drivers have been pounced at and talked to, scolded for and against and still the deaths continue. It is bad enough when the accident is unavoidable. It is doubly bad when the accident and death could have been avoided and in order to impress upon the carelessness and the neglectful seriousness of the crime; for crime it is; prison sentences seem necessary.

Reckless and careless driving on the public highways and on the streets of the communities will have to stop. The danger is not alone to those who ride and drive but is carried on and has reached the point where no one is safe in motor vehicle or on foot.

The careful and conservative driver is in almost as much danger as the careless and reckless driver, and it is against the latter that the prison sentences are brought. The lesson is hard but there seems no other way. When drivers know that the penalty is severe, when they know that their careless indifference to the rights of the general public will be paid for by themselves through the medium of prison sentences, the disregard for the rights of others will disappear.—Times-Register.
