## BRUINS WIN FROM BUHL GIRLS LOSE

Buhl Girls Win One-Sided Game from Twin Falls Girls. Coach Plastino's Quintet Takes Early Lead in West End City and the Final Score Was 30 to 20.

BUHL, Feb. 8.—The Bruin boys and the Yellowjacket girls shared honors last night on the local court before a crowd of 1,400 fans. The Twin Falls girls took the lead from the start and held it for a 20 to 29 win; the Buhl girls ran the Bruin boys' team.

A running account of the game would be one endless chain of Metz-Lacy and Lacy-Metz. The quarter ended, Buhl 32, Twin 0. The half, 30 to 0. In the third quarter, Smith netted a basket for the Bruins and the tally was 62 to 2. Buhl sent in an entire second team in the fourth quarter. No standing room was left after the crowd of 1,400 had jammed themselves into the gym. Between 250 and 300 fans came down with the Bruin squad. The Twin Falls and Buhl pep bands played between periods.

THE TWIN FALLS GAS TAX PLAN

The assurance which the legislative committee who received the highway district boards of Twin Falls, Piler and Buhl last week that they would investigate and give consideration to the arguments offered in regard to why the gas tax should stay put where paid was interesting and hopeful but hardly convincing. Promises to give careful consideration are always on hand in large quantities in legislative committees. A bill embodying the recommendation has been introduced in the house by the entire Twin Falls delegation, all of whom are pledged to back it. The plan is as sound as any tax system now in operation. While the other highway districts of the county were not represented at the Boise meeting, they were all on record in favor of the plan and the same is true of the Twin Falls Chamber of Commerce. The plan involved distribution equitably of the funds raised from gas and the levy of a general tax for state highways so that no community could suffer from the alternative system. It was a step in favor of a real good roads system and the legislature should have done something more than listen and agree to give the matter its "earnest consideration." With our whole delegation behind the measure it should pass.

THE IDAHO POTATO BRAND

The California Produce News, a trade journal of Los Angeles, has published an interpretation of the Idaho potato squabble which is unjustly disparaging to the Twin Falls district. There is some truth in the instances recited, which fact makes an unqualified denial unsatisfactory. The implication that Twin Falls potatoes of inferior quality have been imposed on the markets as "Idaho potatoes" without correct grade designation with the effect of damage to the well-earned Twin Falls reputation is too true. As this abuse has been common knowledge with passive toleration the attack on the Kjosness state grade regulation by local citizens in a measure justifies the charge of conspiracy to perpetuate a fraud. The implication is that public sentiment favors a market system that will permit imposition on the purchasing consumer of "culls" by the fraudulent use of the "Idaho" trade mark.

The slogan "Idaho Potato" is really a Twin Falls trade mark. It was copyrighted at the Chicago Land show in 1910. The baptismal ceremony was financed by the Twin Falls tract and the cost was more than \$10,000 to put the program over. Three full carloads of Idaho potatoes, of the most perfect grade ever known, were distributed on "Idaho potato day" at that great exposition. This was the greatest feature day of the show at the Coliseum was possessed by a mob of over 10,000 every one with an order for a "mess" of Idaho potatoes. Every hotel and restaurant was supplied with Idaho potatoes for service that day. More than 20,000 people in Chicago ate Idaho potatoes that day at the expense of Twin Falls boosters. Epicurean tests of the "Idaho potato" were provided for that occasion with more than a hundred potato competitors. This Twin Falls demonstration established the superiority of the Idaho potato and made the Twin Falls quality the standard for U. S. grade No. 1 which has universal application.

What is now the Idaho russet was made famous by authoritative tests by the best judges of quality that were ever assembled for such services. These experts were secured from federal, trade and college sources. At the end of three days this committee pronounced the Twin Falls russet the best example, out of 3,000, of combined qualities of superiority. The Idaho potato quality which commanded the best market for 17 years was the Twin Falls quality exclusively. Twenty thousand users of that one day of universal sentiment have maintained the market demand, and in the face of impositions made possible by imperfect grade regulations. It is the irony of fate that the Twin Falls tract, the only possible source of quality perfection should be made the "goat" in a political squabble or a commercial imposition. Our market premiums have been sacrificed by grade impositions. The Kjosness grade promised restored premiums for growers as a last hope. Without strict grade regulation our russet premium will never be restored. The russet is a Twin Falls special product. Twin Falls product made the russet and only Twin Falls quality can rescue it.—Newton Hibbs.

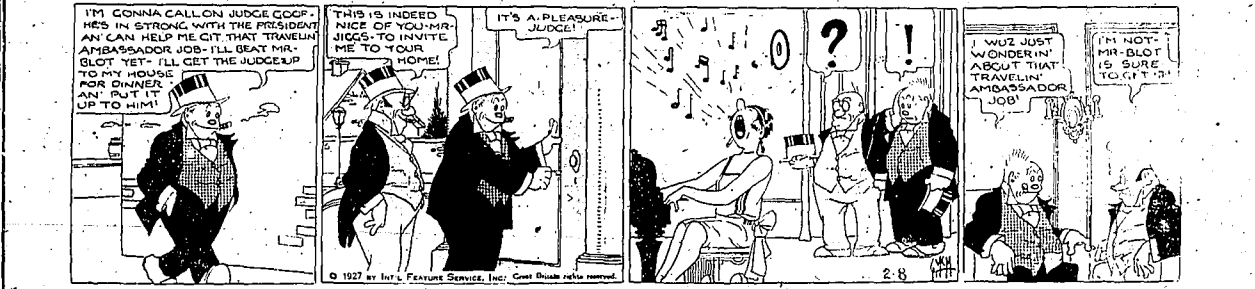
