Sinclair-Fall Trial Is Postponed While Agents Seek Another.

WASHINGTON, D. C., May 12.—The Sinclair-Fall conspiracy trial, originally set for May 23, was today postponed to October 17, to enable the government to secure "flats" and other evidence in connection with the discovery of Harry M. Sinclair, oil man, sought as witness in Europe. Owen J. Roberts, special government counsel, announced that Sinclair, former chairman of the Midwest Refining company, subsidiary of the Sinclair Oil Co. of Illinois, had been served with a subpoena by an American consul about a train between Mexico City and France. James S. O'Neil, former president of the Prairie Oil and Gas company, is the second witness sought. Roberts said he expected O'Neil would likewise be found in Europe. The present case, arising from the Texas Home lease transactions between Albert B. Fall, then secretary of the interior, and Harry F. Sinclair, oil magnate, was originally set for trial May 23, before Justice Fitz of the District of Columbia in the United States.

FLOOD DOOMS NEW DISTRICTS IN SOUTH



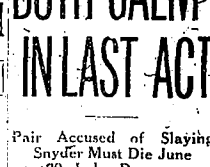
NEW ORLEANS, La., May 12.—Flood waters clipped another sharp section off the Bayou des Cheneaux levee today at Bordelaville in the heart of the flood. The break was gradually cracking outward, dumping the "sugar bowl" lands of Louisiana where 10,000 people have lived and property worth over \$10,000,000 lies in the path of the flood. The break was caused by a series of crevasses between Catopout and Jarcadonville, causing the water to flow through a series of crevasses between the small town of Catopout, already under water and Bordelaville. District engineers said they hoped the water in the bayou would hold. Should the tide break through there, the entire force of the crevasse waters in the Old river "sink" will have a direct outlet through the fertile lands southward. The Bayou des Cheneaux is 120 miles northwest of the river north of there and turned Old river into a great lake which at last has found outlet in the crevasse which came during the night and today.

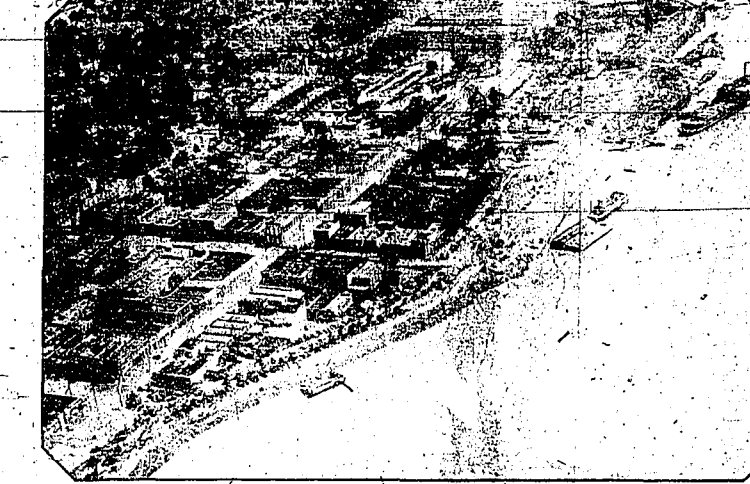
