

THREE D'AUTREMONTS GET LIFE TERMS

CALM REIGNS AT ARMS MEET

Delegates Wait Formal Exchange of Proposals on Limitation at Geneva.

By HENRY WOOD. (United Press Staff Correspondent) GENEVA, June 23.—The European arms limitation conference seemed temporarily localized today by negotiations over routine organization and exchange of information regarding tonnage of warships of all classes sponsored by Great Britain, Japan and the United States.

The technical commission was expected to complete its first list of exchanging technical information today. It was scheduled to report to the executive committee, composed of the heads of the three delegations, tomorrow.

Want to Brown Issues. Hugh Gibson of Britain, Saito, heads, respectively, of the American and Japanese delegations, were understood to have discussed the British proposal to reduce the size of capital ships.

This would re-open questions settled in the Washington armistice treaty, and for that reason is opposed by the United States.

It was authoritatively reported that Saito had refused to discuss positive opposition to the British proposal.

Saito told Gibson that he would accept the proposal to the extent of the Washington 5-5-3 capital ship limits to destroy destroyers and submarines. He intimated, however, his country was disposed to make concessions along other lines.

Japan favors U. S. View. It was understood Japan was inclined to favor the American viewpoint that armed merchant ships presented an important factor in modern warfare. Nevertheless, they have contended arming of merchantmen is unimportant.

Each seemed generally disposed toward the American viewpoint rather than the British on most important points.

LIND CONFERS WITH OFFICIALS

Makes Flight from Dayton to Washington—Will Consider Future.

WASHINGTON, June 23.—Colonel Charles A. Lindbergh arrived here from Dayton, O., at 11:35 a. m., after a standard time flight.

Created by the government's secretary, he planned to discuss aviation with them during the day and to consider plans for his personal future.

Over Bolling field, the trans-Atlantic flier did some stunts to the delight of the small crowd awaiting him.

After greetings by the air secretaries Lindbergh went to the office of Major E. B. Burwell, commander of Bolling field, before leaving for the city where he and his party were to be guests of Secretary of Commerce Hoover at luncheon.

Lindbergh was attired in his famous suit, leather shoes, helmet, and had a parachute strapped on.

DAYTON, O., June 23.—Colonel Charles Lindbergh after spending the night in Dayton as the guest of Dr. Wright, the first famous aviator, left here today at 10 a. m. for Washington.

Edward Arthur Christian George Andrew Patrick David Windsor, more popularly known as the Prince of Wales, celebrating his birthday cake today in one or the other of his various palace homes, while his father, the king, and his mother, the queen, sorrowfully reflect that for more than fifteen birthdays they have said, "next year he'll be married surely!"

It was back in 1911 that the international hullabaloo about finding a bride for Prince "Davy" began. At that time he was betrothed by popular opinion to the daughter of the Kaiser of Germany, Princess Victoria Louise.

And from that first "engagement" he has been variously reported engaged to every eligible girl of royal blood in the continent, except of one or two religions, girls ranging in age from 16 to 35, beautiful girls and homely girls, studious and frivolous.

There are enough romantic tales woven about Prince "Davy" to supply all the operas of all times.

One of the most popular has it that his heart is buried in the unknown grave of the Grand Duchess Tatiana Olga, daughter of the Czar of Russia, who was put to death by the Bolsheviks.

They say that he loved Princess Astrid of Sweden, and was about to make her his when she married Crown Prince Leopold of Belgium.

All his losses were. They say that, when returning from his trip to America, he found deserted Valanda, a girl of his own father and mother, he was all most ready again to please the world by mating. But she returned home to her father's castle.

They say that little Princess Ileana of Rumania pleased him, but that she was killed by a bullet in the head when she was put her in school where she belonged.

328 CONVICTS HOLDING FORT

Kansas Guard and Men in Mine Continue Firm Stands.

LANSING, Kans., June 23.—Hill no sign of weakness on the part of 328 prisoners holding themselves in a mine of the Kansas State penitentiary as a protest against their not being permitted to receive clemency, was shown today, more than 48 hours after the mine and multiple prisoners officials that there would be no giving in to the demands of the prisoners.

Officials are continuing their efforts to get the men to answer the mine telephone, but no reply comes from the mine. The 14 guards held prisoner by the men, who Tuesday refused to come up from the mine because they were not permitted to receive clemency, are still held. It was said when first communication was established late yesterday.

DISCOVER NEW PLOT. HUNTSVILLE, Texas, June 23.—While guards from the penitentiary in the search for 24 of 25 convicts who escaped Tuesday night from Ferguson farm at Midway, one of the boldest attempts at a prison delivery on record here, was made today.

Prisoners inside the penitentiary realized guard strength had been broken and planned to attack the escape Wednesday night, according to Assistant Warden Schramm, who frustrated the plot.

ORDER NELSON TO TRIAL JULY 26

By United Press. WINNIPEG, Man., June 23.—Earle Nelson, winner of Mrs. Emily Norton, 34, and Lola Cowan, 41, in Winnipeg, and suspected of having killed 15 women in the United States, was ordered to trial July 26 by Justice Noble here today.

Nelson will be tried for the murder of the Cowan girl. Preliminary hearings in the Patterson case still are being held.

SAN FRANCISCO, June 23.—Earle Nelson, charged with the murder of a girl and a woman in Winnipeg, Man., is undoubtedly the "stranger" of the Pacific coast, according to Captain of Detectives Duncan Matheson who returned today from Winnipeg.

"The Winnipeg police have a reported case against him, and I have no doubt that he is the 'stranger' we have sought so long," Matheson said today.

"Seven positive identifications of Nelson both on the coast and in the west have been made. There was a marked similarity in all the crimes and the movements of the slayer are easily traced. I think all uncertainty as to the 'dark stranger's' identity has been removed."

WOOD REGIME IS DISCUSSED

Ill Health May Force Governor General of Philippines Out of Office.

By United Press. MANILA, P. I., June 23.—The future of the Philippine Islands was to be discussed today at the temporary White House.

President Coolidge has called into his first vacation conference Governor General Leonard Wood and Representative John C. Tilson, republican floor leader, both of whom have just returned from the islands.

The question of the conference was whether Wood should go back to the islands as governor general despite his ill health. Mr. Coolidge, it is understood, wants Wood to return, believing his regime has been entirely successful and that he is the best man to continue it.

Wood himself wants to go back and finish the job there even if it is necessary to die there with his "boots on," his friends say.

If Wood resigns as governor general, it will be only because of imperative advice of his physicians, the United Press is authoritatively informed.

Tilson came in last night by motor car and went fishing with President and Mrs. Coolidge this morning before he left for Manila. His cabinet conference was gone and he seemed ready to cry.






