

EX-CHAMPION PASSES AFTER AN OPERATION

Tiger Flower Dies After Operation to Eye; Fight Blows Cause Injury.

NEW YORK, Nov. 17.—"Tiger" Flowers, the world's top amateur chess champion, died at 8 p.m. yesterday, following an operation for removing a growth above his right eye. His death was due to an infection at Dr. W. J. Pratelle's private clinic. He died as he was regaining consciousness from the anaesthetic. Announcement was made yesterday that no funeral services would be held in New York, but his survivors in Atlanta, Ga., Flowers' home, will have a private service there.

Blows received in some of his 150 fights had caused the growth, according to Dr. Pratelle.

Flowers was one of the most amazing boxers in the history of golfball. In fact, in the short fury of his attack, he could knock out the man of "Alice," while in the everyday life of his tenderness and play cast him in the manner of a dwarf in a never-never land. A "tiger" indeed.

He was one of the three left-hand boxers ever to win the championship at any weight. Al McCoy and John Martin, the other middleweights, were the other two southpaws who gained titles.

Spud and Flowers were up until 1925, when they gave it up. From 1918 until 1927 he had won 47 of his 131 bouts by knockouts. He gained decisions in 62 fights, was knocked out 69 times and was a draw 12. He fought 260 bouts and ceased to be a no-decision boxer prior to 1927.

Won Title Last Year.

Flowers was the first weight title holder from Harry Green's Madison Square Garden on Feb. 25, 1926, after 15 rounds of fighting. He successfully defended his title against Jimmie Walker on Dec. 3 in the same year. Greh, incidentally, died a few more months under similar circumstances in Florida.

The national boxing association recently issued a statement warning Walker that if he tried for the title again in a few days they would bar Walker from the ring. Flowers, delayed before negotiations were completed for the title bout.

"Clean Out Old Grease." Clean wheel bearings get their lubricant from the grease gun. While the supply of grease in these bearings can be considered adequate, its condition is a point that needs attention. If the bearing has been running hot, it is important to inspect it, for the bearing will be heated with dust and filings. In such a case, it should be cleaned without delay; for these substances play havoc with the lubricating qualities of the oil.

To Remove Tax Saus.
The sulphur in candles can be removed without destroying the candle. Insert the oil, which is applied with a soft cloth, immediately sooty and oily, and dry two spots, and effectively remove those which are not sooty. Reapply to the other parts of the candle, burning the sooty parts, the fat being melted.
