### Woman May Be 'Key' in Brutal Murder of Girl

#### STRONG CLEWS ARE FOUND IN FIEND CRIME

Suspects Nabbed Near Place  
Victim's Body is Dumped;  
Find Blood Stains.

LOS ANGELES, Dec. 19.—Police  
believe today they had solved the  
first big fiendish crime in the brutal  
murder of Marion Parker, 12-year-old daughter, with the  
arrest of a young woman who was  
on suspicion of having been  
involved in the killing.

She was found wandering about  
near the spot where the girl's mu-  
tated body was dumped after  
she had been slain by her father.

The woman, police said, was  
scrabbling hysterically, "I didn't kill  
her. They did it! They did it!"

At the time of her arrest, the woman,  
who says her name is Lillian Padley  
and her age as 22, was slightly  
held on a charge of being drunk.

On arrival, she was booked  
with the arrest of a man, caused police  
to place the more serious charge  
against her.

The man, however, in which there  
was no lead, was arrested in the arrest  
of dozens of suspects during the night.

In addition to the Padley, two  
other women were booked on  
suspicions of murder.

The men are Gaylor Barnaman,  
who was trapped after he called a  
radio station and said he was "the  
fugitive" and William Long, who was  
needed for the arrest of the young  
man suspect.

Long was taken into custody when  
police raffled a house two doors from  
the place where the mutilated body  
of Marion Parker was found by her  
father.

Police made the raid after  
they had watched the suspicious actions  
of a man who had made an  
appointment with the rest of the group  
at the rear of the house.

The man was captured in the front  
of the same house. Police suspicion

#### \$100,000 REWARDS ARE OFFERED FOR CAPTURE OF CHILD'S SLAYER

Grief-Stricken California Determines to Avenge Dastardly  
Murder of Marion Parker; Mother Holds Up  
Bravery But Fears for Second Daughter.

SACRAMENTO, Calif., Dec. 19.—Gov-  
ernor Young today announced he  
would offer a reward of \$10,000 on behalf  
of the state of California for the  
capture of the slayer of his daughter.

The reward was offered in the limit  
permitted under the state law, the  
governor explained.

DRAMATIC AND PATHETIC:  
LOS ANGELES, Dec. 19.—Dramatic  
and pathetic scenes enacted in the  
radio studios of Los Angeles and in  
countless homes throughout the city over  
the brutal slaying of 12-year-old Marion  
Parker.

After the first announcement  
that the child's mutilated body had been

found, descriptions of the murderer  
and his hideous acts were given to  
every citizen to aid in the search.

Then announcements turned to the effort  
of raising a reward.

Frosty winter evenings of the citizens  
and their families and friends were  
spared the terror of the Parker's  
dead end was shown in the flow of  
dollars that today had amounted to  
more than \$100,000 toward the capture  
of the child killer.

George E. Farnsworth, of the San Fran-  
cisco Examiner, who has been making  
the rounds of the city since the  
slaying, said: "We have never seen  
such a spirit of disinterestedness before."

After the first announcement  
that the child's mutilated body had been

found, the happiness of the Parker  
home was shattered.

But the mother, stunned by the  
news, sat silent. Then Marion, who  
climbed upon the home and kitchen to  
safely only fire days ago, bravely  
walked off a complete breakdown.

She walked to the front door, took  
off her coat, and then, in her bare  
body, ran across the room to her  
brother, unknown to her, who had  
held the torn, torn flesh of his  
son, torn to pieces.

Mr. McDonald, told him during

aware of her own danger, had  
concerned her mother and her fa-  
ther.

"Don't be afraid," said Marion, con-

had slept little, but very little. Every  
moment physically possible had been  
devoted to the care of her son.

She had been weeping and in

"I don't know how she held  
out so long," said Marion. "She  
had the heart of a lion."

of mother love that one must feel  
for the people against the Mexican  
government.

Marion's final documents were  
left in the hands of the attorney  
general of the state, who will  
see that justice is done.

Further examination of the scene  
revealed about a half dozen scars  
of cuts and scratches on the body.  
In blood, it was believed, he  
was possible to see the tragic end.

#### BODY OF AGED LOCAL MAN IS FOUND IN HOME

T. H. McDonald Is Believed  
Victim of Exhaustion  
in Recent Storm.

Believed to be the first victim of  
winter in the Twin Falls area, T. H. McDonald  
was found in his bed in this two-room  
shack one and three-quarters miles  
south of the east end of Main street.  
He was so exhausted, said Mrs. McDonald,  
he could not have left his bed in  
two weeks. He was between 70 and 80  
years old.

After failing to see him about  
the house, Mrs. McDonald, her son,  
T. H. McDonald and Mr. Rosel, relatives,  
went to the house this morning.  
They entered the house by forcing  
the kitchen door in.

clothed with his feet tucked  
into a crumpled hamperchief in his pocket

## SNOWDEN CASE IS UNDER WAY SECOND TIME

Sentencing of a jury occupied the time at Circuit Court yesterday in the second hearing this term on the case of the state against George L. Snowden on a charge of burglary in the first degree. The case before the judge was the same as in the first hearing, the conviction of a jury this morning and the selection of a jury occupied the entire morning. The trial of Snowden the 12 men who composed the jury sat from 9:30 a.m. to 1:30 p.m. One juror had been excused from the first 12 cases to the box during the morning session.

Before the panel was called into the courtroom this morning the names of the jurors were added to the information by George W. Wilson, attorney for the defense. They were G. D. Johnson, W. H. Wheeler and Carroll M. Meritt.

Four spectators were in the courtroom this morning.

The jury in the first trial reported Dec. 5, when the trial was adjourned, locked on the case and was allowed to leave by Judge Easton. Following the report of the jury, the defense requested an adjournment of the trial of the case and Prosecuting Attorney Wilson indicated that this would be necessary to the state.

Snowden, who was in court today on crutches, with Jim Kelley and C. Kimbrough, was charged with first degree burglary in connection with what he was accused of attempting an attempt to rob the Diamond Jewelry company of Twin Falls on the morning of Sept. 25, last.

## ANOTHER CHURCH QUARREL...

The controversy between groups of the Church of England is to say the least, resulting in no good for them or other denominations. Add to this the fact that the house of commons of Great Britain refused to approve changes in the church's books of prayer and there is created a combination of church, state and politics that can only cause disgust to many members of the Church of England and others.

The 19-year-old Archbishop of Canterbury, who is reported to have labored for 21 years to revise the English book of prayer (it was promulgated in 1662) is destined to be near collapse from some row brought on by the status of affairs. To aggravate the difficulties there now is reported a movement to split the church between the so-called "low church" and "high church."

The proposed book of prayer sought to smooth over the trouble between the groups by authorizing alternative communion services and this service was the real cause of the trouble. One service would have been that roughly corresponding to that of most Protestant churches. The other was a concession to "high church men" who form the Anglo-Catholic party, and who favor reunion with the Roman Catholic church.

The trouble will serve only one purpose and that is to cause more distrust that churchmen's word over advice is growing in the mind of the "man on the street" for church is general.

Religious strife should cease. No good is being accomplished and certainly a vast amount of time and energy is being wasted among the various denominations. There is enough misery in the world. The work of all churches should be to alleviate suffering as much as possible and to create a desire in the heart of every man to trust and worship the Creator in such a way that he will be assured of a life of peace and joy in the hereafter.




