SALMON SETTLER'S CALL

Land Board to Hear Objections of Settlers January 25, in Boise.

Consideration of an offer from one of the timber companies of the northern part of the state to purchase the timber of seventeen hundred acres of state land at a price to approximate sixty-eight thousand dollars, the necessity of securing patent to two hundred thousand acres of selected lands in the Clearwater district and the application of the Salmon River Land & Water company that a time be set for a hearing where the water users on the Salmon river project could present their objections to the proposal of the construction company to turn over the riparian works to the operating company, were the most important matters which occupied the attention of the land board at its first meeting since the new administration went into power. Governor Alexander, Miss McCoy, state superintendent of public instruction and Secretary of State Barker are the new members of the board. Attorney General Peterson and Auditor Huxton hold over.

S. H. Hays appeared on behalf of the Twin Falls Salmon River Land & Water company with two matters to offer for the consideration of the board. 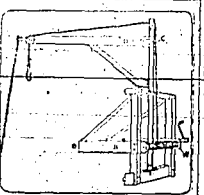

MAKING CORN SHOCK LOADER

Saves Farmer as Much Lifting as Hay Carrier Does in Haying Time—Dimensions of Device.

In response to a query Monroe R. rack bed pieces, far enough back to allow the crank of the windlass to turn without hitting the rack. The windlass should have a catch, which will be found useful to hold the moving parts when going to and from the field.

When in use, let down the swinging arm by unhooking top end of brace. Hook roller hook to front ladder cross piece, then draw windlass up tight and catch. This binds the load while going to the barn.

A little practice will enable the man on the load to tell just when to have the shock lowered as he pulls it over. My corn tines are about five foot long and have wire fasteners. By taking out standard this fence can be taken apart and stored away in 20 minutes, when done using for the season. We think it saves as much lifting as the hay carrier does in haying time.
