MRS. SHEPHERD SURRENDERS ON MURDER CHARGE

Hectic Day of Excitement and Suspense Closes With Mrs. Shepherd at Liberty Until Friday; Accused of Killing.

CHICAGO, May 6 (AP)—After a hectic day of excitement and suspense, Mrs. Shepherd, who with her husband, Wm. D. Shepherd, is charged with the slaying of their young son, John, 11 months old, in the court room of Judge Joseph Hopkins, chief justice of the criminal court.

There, during a strikingly quiet session at the end of the exciting day, Judge Hopkins stayed with Mrs. Shepherd until Friday morning, released her on her own recognizance for \$10,000, and then she appeared in court on the filing of \$40,000 bond.

After it was all over and it had been arranged that Mrs. Shepherd should not like her husband, he is incarcerated in the county jail, the woman who claims to be his wife, gave a woman's love to her millionaire ward and who Judge Joseph Hopkins, in his investigation, yesterday termed a "lady MacBeth," sat in the courtroom outside the courtroom and wept.

"All I have given is love and care," she sobbed, "and all we have gotten is persecution. Oh, if only my boy could be brought back I would gladly sacrifice myself on a cross of iron." The court room scene was devoid of the wrangling and shouting which is expected. Robert B. Crowe, state attorney, raised no objection when Mrs. Shepherd's attorney, who had been called and did not even object when they asked that their client be released on their own recognizance. There is no evidence that I have as state attorney Mr. Crowe said, "that can cause me to oppose bail in this case. I have no objection to the filing of bail in a reasonable amount in both cases against Mrs. Shepherd."

Crowe's Attitude

Mr. Crowe's attitude was the exact opposite of that which she had asked for bail and which the state attorney successfully opposed through the court attorney, who had been the respondent he expressed yesterday when the coroner's jury took action in recommending a verdict of charges against Mrs. Shepherd with the trial of her husband fixed for a date which has been set by Judge Crowe maintained that the action of the coroner's jury would interfere with the trial.

The courtroom session lasted less than 15 minutes. Mrs. Shepherd, dressed in black and wearing a veil, was escorted by a man in a military uniform, who was carrying a camera as she entered the courtroom.

"Why is it?" she asked photographer.

Bodies of Eight in Eastern Explosion Are All Identified

Victims of Blast in Pennsylvania Identified; All Relatives of One Man; Probe Into Disaster Is Started.

PITTSBURGH, Pa., May 6 (AP)—As the city morgue today, three J. Jeremiah identified the bodies of eight persons who were killed in an explosion which destroyed a suburb, early this morning. All the victims of the blast were his relatives. The bodies were identified and identification in some instances was possible only by finding fillings, rings or bits of clothing.

The dead are Clement Jeremiah and wife, Carl Kerig, Mrs. John Baldu and wife, Mrs. Marie Kothe and Mrs. Baldu and aged seven.

Investigation of the cause of the explosion, which resulted in property damage estimated at \$100,000 to \$200,000 was under way before the bodies had been removed from the ruins. Four buildings were destroyed and others nearly damaged.

Poison-Oak Fails To Prevent Agents From Getting Wine

Dry Forces Capture Man and 5000 Gallons of Intoxicants at Oakland, California.

OAKLAND, Cal., May 6 (AP)—Poison oak around a suspected wine store house failed today to keep federal prohibition agents from getting 5000 gallons of wine from being arrested at his ranch at Pleasanton, near here. The agents had when they approached the store house that was covered with the toxicant leaves when they were told that the store house was not used because of the poison oak covering it.

One of the agents, however, plunged through it, only to find that it was not "rooted" but had been plucked there. The agents seized five thousand gallons of wine.

MONTANA MAN TO APPEAL VERDICT

Gordon Campbell Is Convicted of Illegal Use of Mails at Great Falls.

GREAT FALLS, Mont., May 6 (AP)—Gordon Campbell, found guilty here today of the charge that he made illegal use of the mails in promoting an oil syndicate, will make an appeal to the circuit court of appeals at San Francisco. He was sentenced today by U. S. Judge George W. B. Ford of Helena, Mont., his chief counsel. Campbell was sentenced to serve a term of one year in the penitentiary at Leavenworth and to pay a fine of \$10,000 and costs.

PROBE ORDERED IN STATEMENT OF GRAIN MEN

Chicago Board of Trade Acts to Establish Facts of Story Appearing in Papers of Reason for Wheat Fluctuations.

CHICAGO, May 6 (AP)—The Chicago board of trade has authorized an inquiry by a special committee to investigate the statement appearing in the papers of E. Marcy, chairman and E. H. Hahn, member of the board of managers of the Grain Marketing company, that it was developed through speculative manipulation of the market.

In a statement issued in Washington and published in last Monday's newspaper, Mr. Marcy declared that the depression in grain prices last fall and winter was caused by the huge hold of speculators and that but for the artificial technical condition developed through speculative manipulation of the market, prices would have been higher.

Flying Machine to Be Given England Says Orville Wright

Despite Possible Congressional Investigation, Inventor Determined to Ship Airplane.

DAYTON, Ohio, May 6 (AP)—Despite the possibility of a congressional investigation of his charges against the Smithsonian institution and the efforts of a dozen cities and half a hundred museums to obtain the original Wright flying machine, it will go to England, Orville Wright said tonight. The machine will be shipped to Science Museum, South Kensington, London, within two months. It was pointed out that persons interested in the movement to keep the machine in this country hoped that he would delay action until investigation, but Mr. Wright said: "The decision is unalterable, even if I wanted to change it. I have no mileage my way and will keep it."

# SECURITY AT GENEVA MEETING

## Nation Through Spokesman at Arms-Traffic Conference Announces Stand on Disarmament Problem.

GENEVA, May 6 (AP)—France, through her eloquent parliamentarian, Paul Boncour, who presides over the first session of national disarmament, has given notification that national security must be the precursor to disarmament. Addressing the international conference on the control of the trade in arms and munitions today, he expressed the general sentiment of the last league assembly when he defended the Geneva peace protocol. While he pleaded for that sign of mutual confidence and spirit of common assistance among nations which would permit the world to decrease its burden of armaments, Mr. Boncour contended that the successful issue of the present conference would not be secured if it were dominated by another convention checking private manufacturers of arms. And even this could not be sufficient to insure that while force prevailed as the dominating factor in the relations between nations that war would be avoided if the nations sought to become stronger and stronger.

### Outlook of Security

The essential atmosphere of confidence, Mr. Boncour held, would be possible only in so far as it would be the outcome of general security, which had been established to establish peace. The great war, Mr. Boncour thought of a mathematical reduction of armaments for each country, but this had proved futile, for it was demonstrated that in modern wars it was not the number of men but the number of machines guns that counted, but the industrial force of a nation, which permitted quick re-arming. Mr. Boncour had tried to fashion treaties like the treaty of mutual assistance and the Geneva peace protocol, but all were only an effort to put in practice the principle which was the very basis of the league covenant.

# UNION CAMPAIGN MEETS APPROVAL

## Legislative Council of American Federation of Labor Plans to Enlist Members.

WASHINGTON, May 6 (AP)—The most elaborate campaign for organization of sapinion workers ever undertaken in the United States was approved today at a joint meeting of the legislative council of the American Federation of Labor and representatives of 108 international unions.

The United States and Canada will be divided into five districts to each of which will be assigned a selected group operating under the leadership of the Washington headquarters. It is planned that every city and town in each district will be visited during the campaign, which will continue forty weeks. Expenditures will be borne by the organizations interested, about \$12,000 being voluntarily pledged at today's meeting for the preliminary costs.

### Public Meetings

Public meetings, the movies and radio will be utilized in the endeavor to secure the individual worker to the benefits of organized co-operation. Along with the organization campaign will go a concerted effort to popularize and extend the use of union labels on products of organized shops. The district groups are to be headed by the secretaries maintained by the federation and by voluntary workers.

# SEED GROWERS ADVISED HOW TO GET INSPECTION

BOISE, May 6.—All growers of grain, including clover, alfalfa and timothy, are applying for certification inspection by the secretary of agriculture with a \$2 fee, according to G. H. Ahlson, state seed commissioner. The request for inspection and the fee will be returned to the county agent or Mr. Ahlson before June 1.

Mr. Ahlson says it is essential that the seed be inspected by June 1 because of the numerous field inspections to be made this year.

Inspection for inspections will be made up at that time and only the fields that are listed will be inspected. These requirements apply to growers who have received field inspection certificates on alfalfa crops in previous years as well as those springing grain and small seed this year. Growers who have the field inspection certificate need not send in the \$2 fee.

Seed produced by growers who have not made requests for inspection this season or who have not sent in the fee will not be recognized as having seed eligible for certification.

# Treaty Revision is Too Great a Price For America's Help

## French Newspaper Comments on Ambassador Houghton's Address at London: Take New Attitude.

PARIS, May 6 (AP)—Revision of the Versailles treaty would be too great a price to pay for American assistance, the Temps declared editorially today in commenting upon Ambassador Houghton's London speech at the Pilgrims' dinner.

The Temps, heading its editorial "Houghton's Warning," said that the ambassador's words have considerable importance as being, according to Washington dispatches, very clear interpretation of President Coolidge's attitude. The newspaper says the speech may be considered as having been authorized, and as being intended as a "solemn warning" intended to reach every European capital.

### Rights to Ask

"Therefore," said the Temps, "we have the right to ask Americans if in making their assistance, they mean to give up to an American a revision of the peace treaty. If so, it would be paying the debt for its own interest. It is not clear why we should do this, since our security does not permit us to renounce the guarantees given by our soldiers."

The editorial allusion upon Anglo-American friendship, saying that the relations of London and Washington have been parallel since the day of Anglo-Japanese alliance was ended, and that now "there seems to be a new situation in the relations between these two governments."

### Could Abandon Aid

The newspaper observes, however, that the United States could, if necessary, abandon all interest in Europe, clear of all obligations, and withdraw from the security of the continent.

The editorial says that Ambassador Houghton's words are not to be taken as an acceptance of the "Dawes plan," but that Americans will be differentiated between two nations, that is, Germany and German aggression and those proying nations who have brought Europe to its present condition. The editorial added that it was the refusal of the United States to ratify the treaty of Versailles gave rise to the present state of European confusion by the encouragement that refusal gave to Germany.

### Expresses Regret

The Temps concludes with an expression of regret that Ambassador Houghton did not speak in a language which would change the mental attitude and declared that, logically, it should be Germany.

While fully recognizing the excellence of American intentions, the newspaper says that Americans are strongly criticized regarding the sentiments of "the British" and of a majority of the German people.

"It is across the Rhine that America's appeal for a policy of peace and good faith ought to be addressed," the editorial asserted.

# OIL FIELDS OF ARKANSAS SITE OF RAGE RIOTS

## Two Hundred Workers Attack 88 Negroes at Eldorado; Meager Reports Say Some Killed and Wounded.

ELDORADO, Ark., May 6 (AP)—Hitting broke out in the oil fields today as a band of 200 oil field workers marched upon a camp of 88 negroes brought to the field by the Standard Oil company for the construction of a 100-mile pipe line between the Deep sea district and the Mississippi river.

Only meager reports are available here. Several wounded have been brought to Eldorado and reports are that several have been killed. Approximately 100 shots were exchanged between county officers, negro guards and oil workers. Negroes in the camps pushed from their tents in all manners of garb and have deserted the camp, it is said.

### Demand Removal

According to the reports the oil men formed in two groups and went to the foreman of the construction gang employing the negroes. He is reported to have told the men that he would get the negroes out of the field if they would go away and allow him to do it peacefully.

Shots are reported to have been fired from ambush at a general battle followed in which the negroes were scattered as well as the workers. County officers came upon the scene with deputies and officers from Vespette and after exchange of shots both factions were scattered.

### Official Unavailable

County officers and Standard Oil company officials could not be reached. A telephone report at 11 o'clock said that except for occasional sniping all was quiet.

Hospitals at Suncoast and Eldorado have received no wounded thus far, although ambulances at Eldorado have been called to the scene.

The shooting started about ten o'clock tonight and was over in a few minutes.






