# COURT STUDIES BOARD'S ACTION

### Judge H. A. Baker Hears Argument in Proceedings Against Former Commissioners.

Members of Twin Falls county's newly installed board of commissioners and a number of the physicians of the county were interested spectators at hearing before Judge Hugh A. Baker in district court here Wednesday on an order to members of the preceding board of commissioners to show cause why they should not be punished for contempt of court. Judge Baker announced at the commencement of the hearing that division court be rendered in a day or two.

The former commissioners were accused by Dr. J. W. Alexander of Twin Falls, president of the Idaho State Medical society, of attempting to evade the terms of an injunction against carrying into execution a rate requiring payment for services of an anesthetist employed by the county general hospital in addition to charges for use of the operating room. The alleged evasion and contempt consisted in the adoption of a new rule, which required physicians to pay a certain charge for use of the operating room, including services of the anesthetist. J. W. Taylor, former county attorney, and his successor, O. W. Williams, in argument at the hearing Wednesday denied that the new rule violated terms of the temporary injunction, and charged that the terms of the temporary order had been altered in the permanent injunction.



# COUNTY BOARD TO REORGANIZE WEED CAMPAIGN

## No Transfer of Authority of State University Extension Division Contemplated, Members of Delegation Are Told.

Reorganization of the administration of the campaign against noxious weeds in Twin Falls county has been determined upon by Twin Falls county commissioners who took office Monday, but the reorganization plan does not contemplate transfer of authority from the county to the state university extension division.

Statement to this effect was made Wednesday by the commissioners to a delegation of about 30 citizens including Twin Falls Canal company directors and landowners committee members, and to many individuals who are being urged by report that the commissioners planned to assign to the extension division the control of the county acreage over the county heretofore having been controlled that was established about two years ago by E. S. Larned as director.

Commissioners explained that under the reorganization plan the director of noxious weed control will supervise field work and administration of the weed law. The county agent will be designated by the county division with the approval of the county commissioners under contract between the county and extension division, would undertake educational and experimental work in connection with the weed control. It would be expected to cooperate closely with the county weed control director.

A scheme for carrying on the weed campaign under such an arrangement, the commissioners said, had been discussed by the board members with J. H. Reardon, state leader of county agents, and E. B. Brossard, Twin Falls county agent, both of whom the commissioners said, had approved the proposed arrangement and pledged cooperation. The commissioners entered into contract Tuesday with extension division, represented by Mr. Reardon, for retention of the county agent in Twin Falls county for two years. Under the contract the county agent is allowed a budget of \$1000 per year, the county paying the balance of \$140 a month, and expenses, and the state contributing \$1200 a year.

Oppose Extension Control  
Members of the delegation that waited on the commissioners Wednesday expressed concern that the campaign against noxious weeds should be continued and prosecuted vigorously. Several members of the delegation are in terms of commending Mr. Larned's work during the past two years, and two or three of them asked specifically that he be reappointed to continue this work.

Without exception members of the delegation declined against transfer of the county's control over the weed campaign to the extension division or its agents, and one of two expressed criticism of the extension division and its activities among farmers which they said, were impractical.

When Hayward, president of the Salmon River Canal company, said that he attributed to the work of the county weed control bureau during the past two years the fact that the Salmon River project now has its noxious weeds under control. He stated that Mr. Larned had worked effectively in co-operation with the members of the Salmon River tract.

Waterways Interests

Members of the Twin Falls Canal company resolutions committee referred to the fact that the first of the weed campaign against noxious weeds in this county had been launched two years ago by action of the county commissioners at the request of the canal company stockholders. Mr. Larned was designated as director of the weed control campaign after Brossard, county agent, had declined to assume that responsibility, explaining that service of public powers would be incompatible with his position.

## UNION OF TWO BODIES LOOMS

### Merger of Idaho Irrigation Congress and State Chamber of Commerce to Be Urged.

Similarity of aims of the two organizations, realized by members of the Idaho Irrigation Congress at the last annual meeting in Pocatello, led to the suggestion of amalgamation of the two bodies, a program has been proposed was placed in the hands of the executive committee of the congress at that time and is reported to meet with favor in the eyes of members of both organizations.

In view of assumed amalgamation of the two bodies, a program has been arranged for the organization which is expected to pass out of existence, but its members will join in the program that has been prepared by the state chamber of commerce, Mr. Stenwood stated.

Idaho Irrigation Congress  
The Idaho Irrigation Congress was organized some years ago and is composed of representatives of the various irrigation companies, districts and waterways whose purpose has been to study and remedy the problems presented throughout the state in the field of irrigation and water conservation.

Members of the congress may obtain reduced rates by the electric railway in Boise, it was announced by Mr. Stenwood, who is in receipt of a communication from railroad officials announcing the price of a round trip ticket at the low rate. Certification of delegates will be necessary in order to secure the advantages of the lower rates.
