Williams Gets Teacher Plan Of Retirement

BOISE, March 7.—The special session of the Idaho legislature today delivered another piece of major legislation, a bill providing a teachers' retirement plan. The measure was passed by a vote of 40 to 10, after a long and heated debate.

A parliamentary maneuver in the house to defeat the measure, approved senate bill to appropriate \$24,000 for converting the old ironmountain building at Vesper into an Idaho state trade school failed.

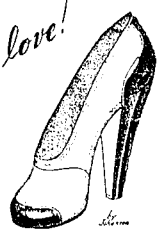
