Truman Declares End to Period of Hostilities of War

WASHINGTON, Dec. 31 (AP)—President Truman ended today the period of hostilities of World War II.

He left intact, however, the states of emergency declared by the late President Roosevelt before the United States went to war and he said that today's action does not end "the state of war itself."

Recommendations will go to congress in the near future, Mr. Truman told a news conference, with respect to cancelling the national emergency and ending the state of war.

His proclamation ending hostilities, effective at noon today, did erase from the statute books at once 20 wartime laws.

Truman Order Ends 20 War Powers Today

President Truman's declaration that hostilities ended at noon today means in brief:

Twenty major wartime powers ended immediately and 21 others will come to an end in six months or soon thereafter.

The government's power to seize strike-bound plants and mines is augmented.

Farm laborers, such as the Mexicans and Jamaicans who came and helped produce bumper war crops, can enter only under regular immigration laws.

The government must return to private owners the seized properties, such as the coal mines, that it now holds.

Many wartime taxes will drop to lower levels (unless congress acts to prevent the fall). Examples: Liquor tax from 49 to 48 a gallon. Puts from 20 to 10 per cent. Long distance telephone rates, from 25 to 20 per cent; on local telephone calls from 15 to 10 per cent.

The proclamation has the effect of setting Dec. 31, 1946, for windup of the wartime government program of price supports for farm products.

Some 500 other emergency laws end on the 31st.

"End of hostilities" in this case is just technical legal language and effects no laws which could be phrased otherwise. There will still be laws on the books until there are new ones to replace them.

Spoiled Spud Purchases to Be Destroyed

WASHINGTON, Dec. 31 (AP)—Agriculture department officials predicted today that millions of bushels of frozen potatoes will be dumped under government instructions during the next several weeks.

They will be part of the 1946 crop surplus of nearly 100,000,000 bushels.

Officials estimated the government's final loss on the surplus will amount to about \$30,000,000.

Here is why the government takes it on the 31st:

Under wartime legislation, the agriculture department underwrote the 1946 crop of potatoes well as many other farm products. It assured farmers that they would get at least 80 per cent of parity—the theoretical price determined to be equally fair to producers and consumers.

The potato trouble developed when the crop turned out to be about 100,000,000 bushels larger, and the department had planned for and bought that much larger than estimated crop.

When this surplus became apparent, potato prices tumbled. And the department was left to carry out its legal obligation to assure growers at least 80 per cent of parity.

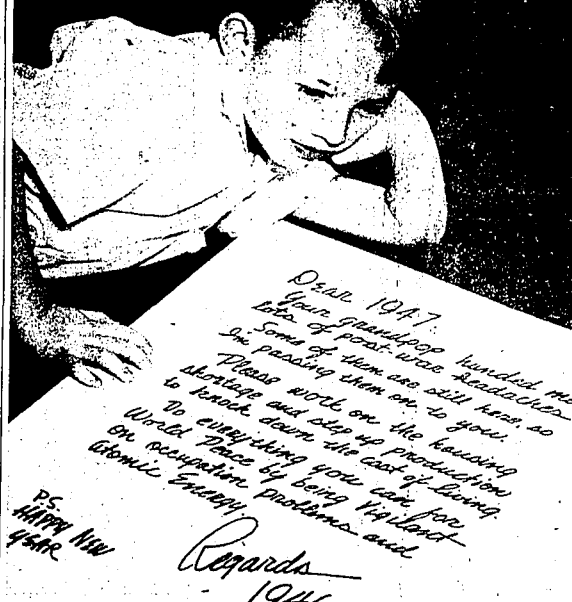

Let's Eat

Yes, make Sunday's dinner substantial. But keep it interesting. Don't fall into a Sunday-dinner rut. Try one of these seasonal treats for the family:

Corn and Tomato Apple
(Serves 6)

One envelope plain, unflavored gelatin, 4 cup cold water, 2 fresh cooked tomatoes or 1 1/2 cups tomato juice, 1/4 cup leaf, 1/4 teaspoon salt, 1/4 cup chopped celery, 1/4 teaspoon pepper, 1 tablespoon mild vinegar or lemon juice, 1 tablespoon grated onion, 1 cup fresh cooked whole-kernel corn, 2 tablespoons butter, 1/2 cup milk.

Soften gelatin in cold water. Mix tomatoes, bay leaf, salt, celery, and onion. Simmer 10 minutes. Strain, and dissolve softened gelatin in hot tomato juice.

Add vinegar or lemon juice and onion juice. Cool. When mixture begins to thicken, fold in drained corn and finely-chopped green pepper.

Turn into individual molds that have been rinsed out of cold water and chill until firm. Unmold onto plates, watercress, or desired greens, with mayonnaise.

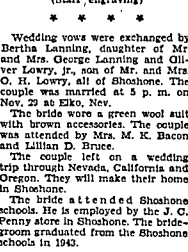

Fund Surplus At 17 Millions In State Now

BOISE, Dec. 31 (UP)—Idaho is in the best financial condition in its history with a cash surplus of more than \$17,000,000, the state auditor, Ruth Moon, reported in her biennial report today.

Mrs. Moon—who turns over her office to Mrs. Lela D. Palmer on Jan. 6—warns that before intelligent planning can be arrived at, an analysis of the so-called surplus must be made.

She says in her report that in nearly every instance surpluses in funds have accumulated from postponement of construction and maintenance programs during the war period. She says also that state expenditures—considering the level of the national average—have been abnormally low.

But the important thing, she said, is that Idaho has maintained its tax rates, paid off all its debts, built reserves and tidied up its financial house.

Management of the reserves is the key to the 1947 budget.

The biennial report—which covers the period from July 1, 1944 to July 1, 1946—shows that the general fund had a free balance of \$7,845,000 on Jan. 1, 1946.

It had a balance of \$11,000,000 on Jan. 1, 1945, and a balance of \$12,250,000 10 years previously.
