

U. S. Aides Fired Over Loyalty Program

WASHINGTON, Oct. 11 (AP)—The government disclosed today that 6,625 federal employees had been fired or had resigned because of the administration's loyalty program.

A service commission released the new figures on Oct. 10. The new total compares with 12,111 employees who had been fired because of security reasons and 4,316 who had resigned because of determination of their cases had been completed.

The commission said that of these who were fired or resigned, 1,743 indicated, in varying degrees, subversive activities, subversive associations, or membership in subversive organizations.

The commission said that in 616 cases it had information indicating subversion, and it said the files of some 2,272 contained information indicating conviction of felonies or misdemeanors.

The new report covers the period from May 26, 1953, through June 30, 1954.

Its release is certain to set off more Democratic Party political debate over how effective the Eisenhower administration program is in ridding the federal payroll of subversive activity and associations.

Sen. Olin D. Johnston, D., R., said last week that the administration claims that a program is "the biggest lie in our American history."

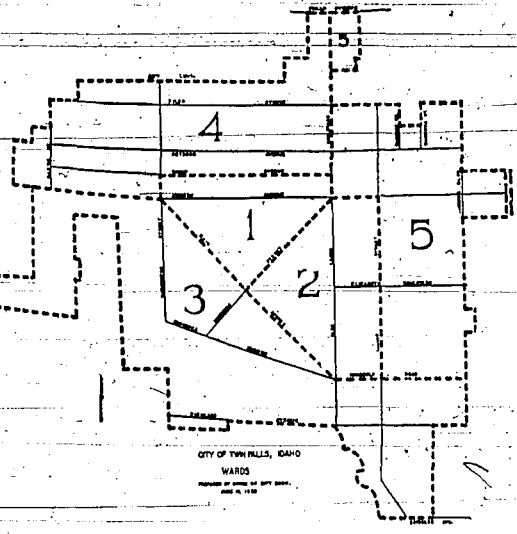

More interest in the election was generated Saturday than other day with a fairly regular stream of persons thronging to the city hall to cast absentee ballots and register before the 9 a. m. deadline.

Three hundred and sixty-six absentee ballots have been cast in the election, reports Mrs. Leifer. New registrations total 1,233 with a total registration of 7,707 voters.

In the last liquor-by-the-drink election, June 1953, voters jammed the city's three voting places to cast 5,646 ballots.

Polls for Tuesday's election will be open from 7 a. m. until 9 p. m.

GOP Levels Blast on New Hopefuls in Vote Campaign

Republican campaign strategists in Idaho are pinning their hopes on a barrage that promises to echo until election day, just three weeks off. The prime target appears to be Glen Taylor, Idaho's onetime singing cowboy senator who is trying a comeback on the Democratic ticket. In Boise, Republican State Chairman Wally Burns said that Sen. Herman Welker would arrive home from Washington this week to make the first of two or three speeches in behalf of Sen. Taylor.

Welker has promised he will concentrate his fire on Taylor. Burns said Taylor had "tried to convince the American people that the Chinese communists were merely agrarian reformers."

He challenged Taylor to say whether he is for or against the admission of red China to the United Nations.

Burns quoted a remark he said Taylor had made on the senate floor March 1949, that the Chinese communists "are rather mild socialists with a program of agrarian reform; that they make a sincere effort at honest government in the areas they hold; and that they are the coincidence of the Chinese people."

Meanwhile, the major candidates for the senate are pinning their hopes on a large population center this week. Taylor and his Republican opponent, Sen. Henry Dworshak, more than Canyon county, Democrats will get campaign assistance from Rep. Harold Cooley, D., C. chairman of the state senate agriculture committee during the Truman administration.

In an speech at Idaho Falls Tuesday, Cooley said he would support the Republican senator, Herman Welker, who probably will return to the senate after his term as a state legislator expires.

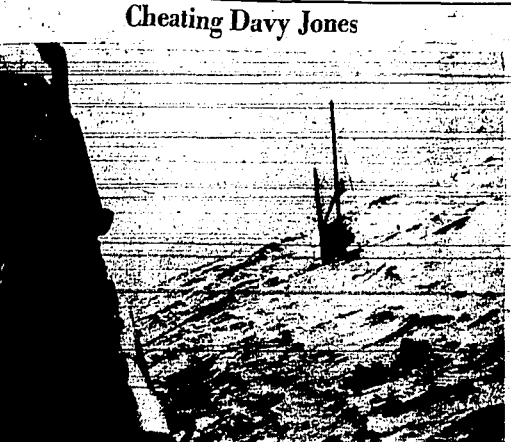

At the moment, their chances of pulling across their state ticket look rosy.

The major prizes in Wisconsin are the governorship and 10 house seats. All the incumbents are running—GOP Gov. Walter J. Kohler for a third term, and eight Republicans and two Democrats in congressmen.

McCarthy's term was four more years to run. He hasn't been back home for any speeches since June. State Republican leaders say there are no plans for any before the Nov. 2 voting.

Most people out here simply aren't talking about McCarthy.

Benson Cites Confusion on Ballot Drives

DAVENPORT, Ia., Oct. 11 (AP)—Agriculture Secretary Ezra T. Benson said today he doesn't even recognize himself in some of the flood of current campaign material.

"I suppose it is natural considering the fact that we are approaching the month of November in an 'election' year in that the American public should be much more confused than enlightened about administration farm plans," Benson said.

"I confess that sometimes when I glance at certain papers and read what a certain person is allegedly attempting, I don't even recognize myself. Not until I find my name mentioned somewhere in the body of the article do I realize that I am the person referred to."

In a speech prepared for delivery before a national Catholic Rural Life conference, Benson said the basic principle behind the administration's efforts was best stated by Abraham Lincoln when he said: "The legitimate object of government is to do for a community of people whatever they need to have done, but cannot do at all or cannot so well do for themselves in their separate and individual capacities."

Benson called for a "concerted attack" by public and private agencies on the problems of low-income farm families. He said in 1950 1,250,000 farm families had incomes below \$1,000 a year. Now it is possible he said, for families "to get along decently" on less than \$2 a day.

Benson said efforts to "lighten the burdens" of low-income families already have been made by the government but he said more progress has been "piecemeal." "Now is the time for a concerted attack," he said.

Reds May Return Lend-Lease Ships

WASHINGTON, Oct. 11 (AP)—American officials predicted today that Russia will agree soon to return another group of naval craft which were loaned to the Soviet Union during World War II.
