Signers Were Slow in Okaying Declaration of Independence

NEW YORK, July 4 (UPI)—Is not America already independent? demanded Samuel Adams of Massachusetts after the colonial forces had fought three battles against the British.

"Then why not declare it?" But the statement of 1776 moved toward independence. Nonetheless, the framing and adoption of the noblest document in political history.

The North Carolina legislature voted on April 12, 1776, to join the colonies in a declaration of independence. Virginia on May 15 voted to initiate the declaration. And on June 7 one of the delegates, Richard Henry Lee, arose in the continental congress, and moved that:

"These united colonies are, and of right ought to be, free and independent states."

Helped by the wisdom of Benjamin Franklin and John Adams, young Thomas Jefferson composed the historic document in 18 days. To him it was more than a political statement. It was a profound testament of the imperishable rights of all men.

It seems almost as if who weren't present when it was first passed. The final signature—that of Thomas McKean of Delaware—wasn't affixed until 1776.

What sort of men were they who signed the historic document? Not at all the immature or irresponsible freethinkers types often associated with revolution.

Many were some of the great leaders for liberty of the period, including George Washington, whose tool then was the sword rather than the pen. Here to win the Encyclopedia Americana has to say on the subject:

Only two of the 56 signers were bachelors. Sixteen were married twice. The signers fathered 325 children—George "Patron" of Virginia leading with 18.

Slightly more than half were Episcopals. The rest were Congregationalists, Presbyterians, Quakers, Baptists and Catholics. Ten were the sons of preachers.

The list of names to die—and the oldest at the time of his death—was Maryland's Charles Carroll of Carrollton. He lived to be 85. The first to die after the signing was John Morton of Pennsylvania in 1777.

Some paid a costly price, losing their lives and fortunes in the Revolutionary war. None lost "his sacred honor."

Some died violently. George Whyte of Virginia was poisoned by a hand grenade impatient for political rival.

George was killed in a duel with a political rival.

However, most of the signers remained active in public life. Two later became U.S. presidents—Jefferson and John Adams. Elbridge Gerry served as vice president under James Madison.

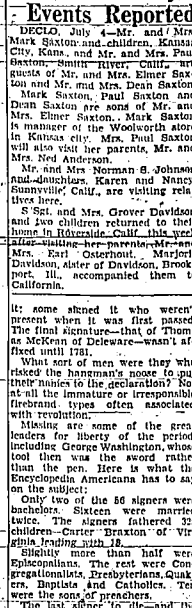

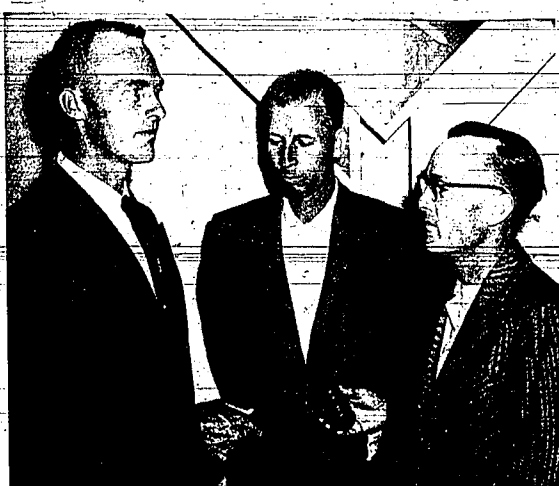

Care of Your Children

By ANGELO PATRI

Now and again I hear a young mother tell a small child not to do something that will endanger him or her. The child, in the tone of his voice is questioning rather than firm and positive. A small child who is to be the tone of voice that is used in telling him to do or not to do and he responds accordingly.

A small boy on the kitchen floor banging a metal spoon on a metal bowl. "Willie," Willie blinked at her once and resumed his noisy thumping. Again his mother said, "Stop it, Willie," and again he blinked and continued his enjoyment of the racket he was making.

His grandmother, from her chair nearby said, "Stop that," and he stopped. His spoon in mid-air.

"You didn't speak hard to me," said Willie. There must be that chord of hardness in the voice of command if obedience is to be expected. Where small children are concerned, prompt, unequivocal obedience is essential to their welfare. Mothers must not be afraid to command it and get it.

Prompt obedience in small children means security for them. They learn that father and mother give orders only when necessary. They learn, too, that obeying brings them only good. That breeds trust in the affection and the love of their parents which gives them the much-to-be-desired feeling of security.

Knowing that a little one can be depended upon to obey a command relieves his mother's anxiety. That is worth working for in itself. It does take work. A mother might have to take pains to time off to teach a small child to stay within the boundaries of his home place but once she gets him to understand that he must stay inside those lines his mind is freed and her child is safer.

Parents must not be timid about teaching children that there is such a thing as "must." They are going to meet that all the years of their lives. If they learn its inevitable
