WASHINGTON, May 22 (AP)—The agriculture department said today it will move some 42 million bushels of grain out of elevators owned or operated by Billie Sol Estes, Texas financier now under indictment for fraud. In another development, a subcommittee announced it will open public hearings Monday on the Estes case. Its chairman, Rep. L. H. Fountain, D. N. C., pledged an investigation that will "lay all the facts out on the table."

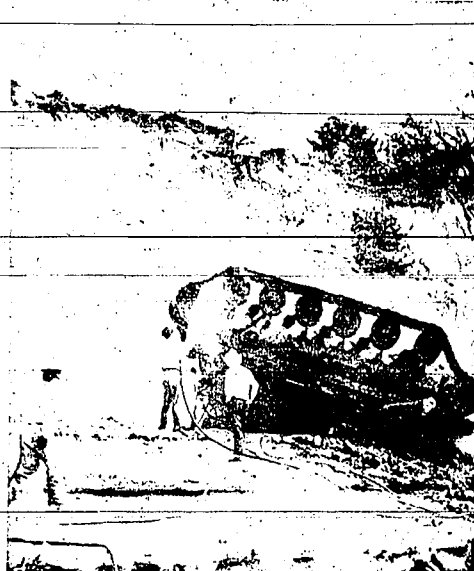

No Parking Plan on Blue Lakes Opposed

Representatives from the Twin Falls Episcopal Church of the Ascension protested against a state highway proposal to eliminate parking along Blue Lakes boulevard north at the Twin Falls city commission meeting Monday evening.

In a letter sent to the commission, the state highway department suggested the city eliminate its parking along the street and turn the road into a four-lane highway.

"I suggest that the street be widened from sidewalk to sidewalk. In this way, parking space will still be available," Robertson suggested.

Plane on German Mission Crashes; 27 Persons Dead

EBERSBURG, Germany, May 22 (AP)—A four-engine U. S. army plane on a secret mission exploded, crashed and burned today, killing all 27 persons aboard. U. S. authorities at the scene said at least 20 bodies were recovered. A spokesman at American headquarters for the military said that the plane was on a routine training flight.

The plane was based in Tora, Spain, and had flown to Frankfurt, but had planned to return there before taking off for Ebersburg. The plane plummeted in an open field near the south Bavarian town.

Many Germans reported hearing a loud explosion. Several Germans said they saw the plane crash in the air several times before crashing.

First to reach the scene was a German plane from a flight instructor. He said he and other would-be rescuers were unable to get close to the plane because of the flames. German fire fighters finally brought the fire under control.

An alarm brought 14 German fire engines to the scene 10 miles from Ebersburg. The wreckage of the plane was found at an altitude of about 5,000 feet out of a completely clear sky.

1 teaspoon Worcestershire sauce

Quilted cooking foil (broiling)

Marinade roast in mixture of vinegar, oil, lemon juice, salt, pepper and enough water to cover meat, at least one hour.

Line firebox with quilted cooking foil. Add charcoal, light and let burn until coals are covered with gray ash.

Secure roast firmly on barbecue grill outdoors. As roast turns slowly, baste frequently with mixture of pineapple juice, barbecue sauce and Worcestershire. When roast is done to golden brown, remove from barbecue and place on warm platter. Arrange close-studded pineapple slices on top of roast.

Close-studded Pineapple Slices

Arrange four pineapple rings on quilted cooking foil (broiling). Stud with cloves. Fold over foil to completely encase pineapple. Place foil packed on coals about 30 minutes before meat cooking time is up.

The meeting season will start at 10 a.m. and will deal with profit planning by means of integrated budgets.

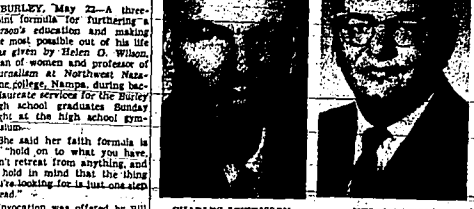

Hoffa Says Indictment Was Framed



PHILADELPHIA, May 22 (AP)—James R. Hoffa, Teamsters Union president, says the Kennedy administration deliberately framed an indictment against him to cover up the \$100,000 racketeering scandal in Texas.

Hoffa, at a news conference Monday, said his indictment last Friday at Nashville, Tenn., was handed up by a federal grand jury for the purpose of covering up the "Ester case and to cause a scandal."

The two-count indictment in Nashville charged Hoffa with violating the anti-trust laws and collecting some million dollars illegally. 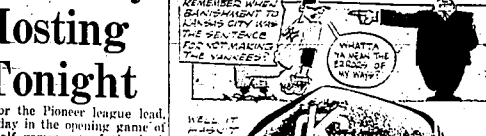

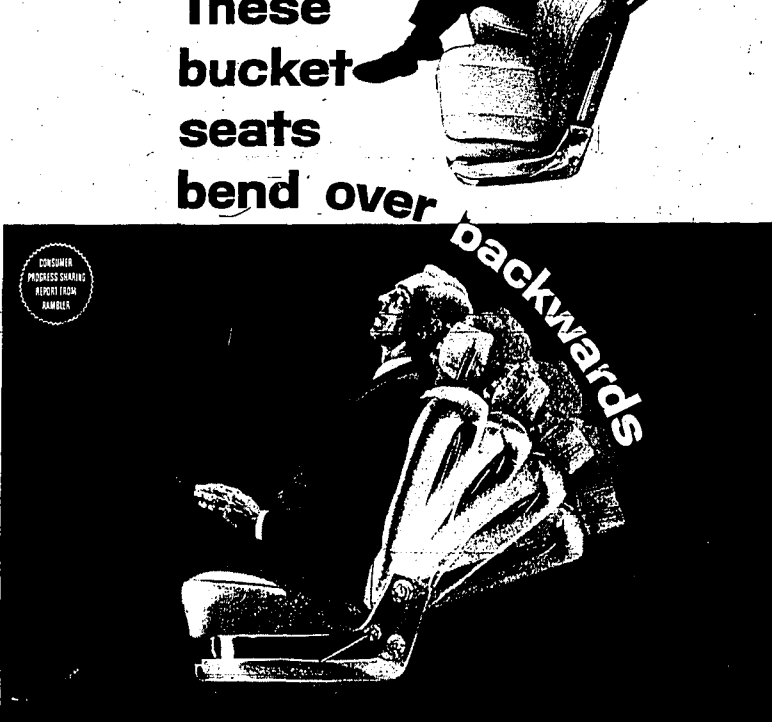
