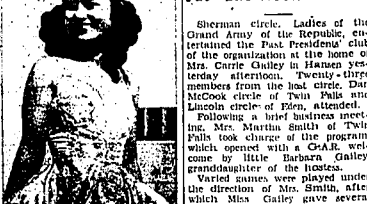

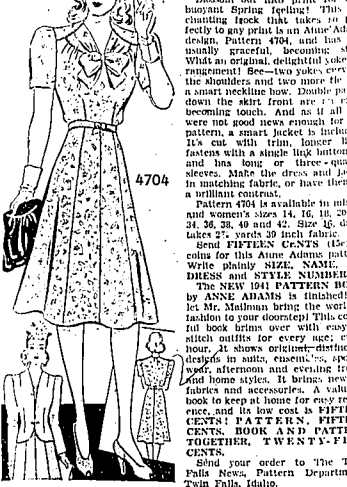

# HOUSE APPROVES LEVIES REVISION

## Swift Action Taken for Aid of Excess Profits Taxpayers

WASHINGTON, Feb. 25 (AP)—Swift action to all corporations and persons suffering hardships from the excess profits tax is taking to day by the house, which approved with little debate a bill revising details of the law.

The measure, introduced with administration support only yesterday, now goes to the senate.

Chairman Donahoe (D-N.C.) of the ways and means committee explained that the bill was intended to eliminate unfair discriminations, said that about \$20,000,000 would be paid back to the taxpayers this year and that about \$70,000,000 would be saved by repealing the tax.

Further Revisions

Still further revisions may be needed, he added, as the excess profits tax law continues to operate.
