HENRY G. KRUSE

IN THE untimely death of Henry G. Kruse, Vinton, Iowa, newspaper man and one-time publisher of the Evening Times, keen sorrow burdens those who knew him, and makes them wonder why such a seemingly uncalled-for tragedy should be.

Of a kindly, yet vigorous disposition, he was an inspiration to journalism for his straight-forward qualities, his policies which had won success in his chosen field, and for his broad sympathetic attitude, which seemed to be attuned to the needs, the struggles, the ambitions and the hopes of the people whom he served with constaining happiness and absorbing interest.

He knew the trials and tribulations of poverty and struggle; battled seemingly insurmountable obstacles in his younger days to victory and the crown of success. An indefatigable worker, careful as he was through three score years, from horse and buggy days, to this modern 1931, he fell, the hapless victim of the automobile, the epitome of the machine age of which his very business was an outstanding counterpart, for certainly the newspaper and printing office is the height of modern invention.

Man's utter helplessness against the grinding strength of inhuman machine power is one of the penalties exacted in payment of the advantages which accrue in faster transportation, increased production, and delivery from toll, drudgery and routine.

H. G. Kruse of all others would not change this, but the pity of it all is to see those who managed to live successfully through the days of old-fashioned, impediments, reach an untimely end amid surroundings which thirty or forty years ago would seem to them strange indeed.

But he died in the full strength of his powers, cut down at the high tide of his career and in the midst of busy, happy, successful life; surrounded by his family on a happy excursion. The alternative, perhaps, was for him to live into retirement, to let the infirmities of old age or disease rack his body and mind, with years of suffering before death came to give succor.


Like the rest of us, he had no choice in the matter, and perhaps that is best after all, though life meant much to him.

Well may it be said of H. G. Kruse, that he left a monument of friends and service and radiant optimism, that will not soon be erased.

His life was forceful, purposeful, abundant, and though it ended unexpectedly, suddenly, tragically, it was not before he had fulfilled his destiny.

It is something to regret the things you have done, but much worse to regret the things you did not do.



If personal checks are sent in, make them certified at the bank, depositors' cashier's checks will not be issued until checks have been paid.


