Lindberghs Believe Boy Alive; Onetime Kidnaper Questioned

TAXI DRIVER ALSO ENTERS MYSTERY INVOLVING INFANT

Commission Rules Against Pullman Company Appeal

WASHINGTON, (UPI) — The Interstate commerce commission today ruled that the Pullman company could not charge an extra charge on sleeping berths which are occupied by two persons.

John O'Gorman, attorney for the commission, told the court he applied for permission to make an extra charge when two persons occupied a berth, arguing that the situation was comparable to that of two children in charge of a room when two persons occupied a room.

ROCHESTER, N. Y., (UPI) — Stanley Crandall, questioned by Rochester police at the request of New York state having satisfied local officers of his movement, Police Charles A. Lindbergh Jr., was kidnapped.

Crandall, a paroled kidnaper, failed for police every movement he made since February 4 until today. Chief of Rochester Detectives John P. McDonald said:

"HOPKINS, N. J., (UPI) — Col. Mrs. Charles A. Lindbergh clung to the belief that their kidnapper had been captured and was still alive, according to an unpublicized information given to the United Press. Reasons for this belief were not given in detail."

Meanwhile, authorities uniformly ran down scores of leads and clues without contributing positively to the mystery of the disappearance of the infant or its kidnappers.

A former kidnaper, Stanley Crandall, now on parole, was detained in Rochester, N. Y., and remained incommunicado.

In recent days, on the police docket, all known kidnappers at large ought to be checked.

John J. Shanahan, New Jersey police, gave out a statement of Kenneth Schaefer, an Easton, Pa., taxi driver, who drove myriad passengers, including several kidnappers and claimed that at their behest he took verbal notes saying:

"Baby safe, you can't get me," plus "I'm in Direct Command of Lindbergh Home." Call Spittale (Lindbergh's old boy) from Longacre, important, (Longmeadow, N. Y., code phone) 2-1200.

The police said an investigation of his story of his strange passes and their strange maneuvers had not proved any facts of value.

State's Unemployed Estimated at 20,000

About 6,000,000 Jobless in U. S. Says Sen. Bingham

WASHINGTON, (UPI) — Senator Bingham, Rep., Conn., submitted to the Senate today an amendment to the bill to extend unemployment compensation which would increase the number unemployed in the United States and accompanied it with telegrams from the governors of most of the states upon which he was able to keep.

The information was offered as part of Bingham's efforts to defeat the proposed \$12,000,000 emergency road building program which would have been directed against an "excessive" amount of unemployment.


