



# "I WILL BE A FIGHTING CHAMPION" — SHARKEY

## American's Left Wins Decision in Battle for Title

NEW YORK (UP)—Jack Sharkey today challenged the heavyweight fighters of the world to come and get the world's championship he took from Max Schmeling last night—a title many critics said should have remained the German's.

Within 15 minutes after the two judges decided Jack had defeated the dark haired German—thereby restoring the title to the United States—Sharkey announced he would be a "fighting champion."

"I won the title honest-ly," he said. "Now I will defend it. I will be a fighting champion."

What matter to him, the hoos the crowd gave the decision? What matter the protests of Joe Jacobs, Schmeling's manager; what matter his own closed left eye?

Left Wrist Title

"I was not hurt," he said. "I am going back to Boston and will decide on my next plans. But you can say for me I will keep on fighting."

Sharkey drove his left hand to the heavyweight championship of the world.

The 75,000 fans in the now Madison Square Garden howled, cheered, roared and waved their arms in the air, some waving their hats and some waving their hands. Other times it was painful. Other times it was a fainting spell which blocked the German champion.

In the late rounds, Sharkey's left seemed to lose its sting. Schmeling rallied. He jabbed a left that had been almost tied in early rounds. He finished a hard right which parried Sharkey and closed his left eye.

In fact, Schmeling came back so strong that at the close—the crowd waited tensely for the verdict—there were faintest glimmers of "left Maxie." When the decision was announced, however, cheers and howls greeted it. The crowd was cheering as if the fight had been the sentimental favorite.

The crowd was not happy that Schmeling had the referee, George Kelly, a judge, overruled Charley Mitchell, who thought Schmeling had hit the referee, Joe Jacobs, Schmeling's manager, called the decision a "robbery." He recalled that last week he threatened to keep his man from the ring if a certain man was referee. Sharkey he said he meant "Gardner."

Sacks said he would begin negotiations at once with a view to signing the hot here on Labor Day.

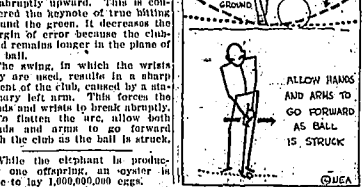
## GOLF

# SOCIALIST PARTY DRAWS PLATFORM FOR CANDIDATES

## W. C. Porter Is Chairman Of Convention Held Here Tuesday

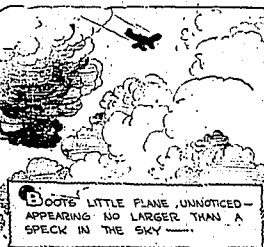

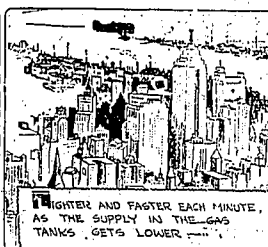

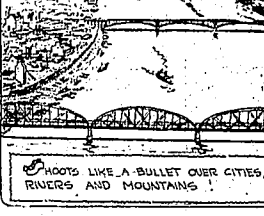

## U. S. OFFERS TO REDUCE BURDEN OF ARMAMENTS

(Continued from Page One)

American taxpayers \$2,000,000,000 during the next decade.

The President proposed the following five principles to guide the world toward arm reduction:

1. The Kellogg-Briand pact, to which we are all signatories, can only mean that the nations of the world have agreed that they will use their arms solely for defense.

2. This reduced should be carried out not only by broad general cuts in armament but by increasing the comparative power of defense through decreases in the power of attack.

3. The armaments of the world have grown up in general mutual hostility to each other. And, since the generally, such reduction should be carried out in making reductions.

4. The relations must be real and positive. They must effect economic relief.

5. There are three problems to deal with: Land forces, air forces and naval forces. They are all interconnected. No part of the proposals which I make can be dissociated one from the other.

After emphasizing these principles, the President declared: "Based on these principles, I propose that the arms of the world should be reduced by nearly one-third."

17 Holstein Cows Owned By  
A. J. Jagels Tops 345  
Pound Fat Mark

WASHINGTON (Special to the Evening Times)—The registered Holstein herd of 17 cows owned by A. J. Jagels of Blain, Idaho, has completed its first year in the herd improvement registry test and averaged 1122 pounds of milk and 2155 pounds of fat. According to the Holstein-Friesian association of America all three cows in Class 3 (three milking a day) and the cow owned by Jagels, which was named by the owner as "Jagels", which yielded 12,821 pounds of milk and 4978 pounds of fat. Two other cows in the herd averaged 300 pounds of milk and three and four-year-olds averaged 1122 pounds of milk and 2155 pounds of fat.

The herd test was started four years ago by the Holstein association and is proving quite popular as it offers an excellent means of obtaining records in a herd each year and serve as an invaluable aid in proving herd sire and cow for California. PLANKETY PLANK!
Senator Borah has done the expected. Idaho Republicanism having its hands full as it is, now has, as the result of the national prohibition platform, the Senator's diatribe and a few other things quite sufficient to keep it in a stew from now until the votes are counted next November.

Senators Thomas and Congressman Smith, arch-supporters of the Hoover administration are placed in the menacing position of receiving the cross-fire. They cannot follow both the President and the Senator, and they are now candidates for reelection on the lately adopted platform of the Grand Old Party which contains a modification clause which they heretofore have strongly opposed, not ever countenancing thoughts of a referendum.

Now Borah withers this great document by denouncing it and its framers because it is too wet, while Nicholas Murray Butler, in a wringing statement says the plank and as well as the platform itself should be repudiated. He says 37 of the 97 delegates from New York were office-holders and upward of 400 of the convention's delegates were officeholders, which he describes as "repugnant to Republican traditions." Well he ought to know.

Butler continues by saying he had been deluged with telegrams from all over the country, the general tenor of which is: "We're through. No matter what the Democrats do, it can't possibly be as bad as what the Republicans have done." And the university president, a stern Republican mind you, adds this: "The Democrats appear to have a wealth of material for the presidency and there is a dearth of leaders in our own. Twenty-five years ago we had all the talent. Now the Democrats have it all."

The plank adopted at Chicago was sired by mud-head out of cowardice. Instead of having gotten out of the prohibition middle, we are only deeper in than ever. Borah maintains on the other hand that the plank spells the death-knell of prohibition and believes his party now is unalterably for repeal, a situation he cannot reconcile, and on which he deplores.

Just how he and Mr. Butler and Mr. Hoover can get together is hard to determine. Truly the thing is a mess. As was pointed out in these columns the day after the platform was adopted, the plank certainly is revolutionary. And what is more, the reverberations are apparently without end. We shall presently hear more of the matter.

A PARALLEL CASE FOR GERMANY
Probably history never exactly repeats itself, but now and then it comes close enough to give nervous shudders.

Right now students of the European situation are asking themselves if Republican Germany is about to follow the course steered by Republican France in 1848. There are two or three little indications that it may; and, if it does, all a lover of peace can do is pray that history will repeat itself so far but no farther.

In 1848 France was a republic. Napoleon Bonaparte had been gone for more than three decades, and with him had gone—as Frenchmen saw it—all of the glory and prestige that France had had under the first empire.

So, in that year, the French elected as their president Prince Louis Napoleon, nephew of Bonaparte. The election came as a climax to a turbulent year of revolution—a year not greatly unlike that which Germany is living through now. And shortly after his election, Louis Napoleon changed France from a republic to an empire and had himself proclaimed emperor.

The emperor then led his nation into an erratic foreign policy that culminated in the Franco-Prussian War, in which France suffered a crushing defeat and almost declined to the position of a second-class power. The parallel with modern Germany is inescapable. Germany has lost her emperor, as France had lost her Napoleon. Hard times have followed his departure. The power and the glory that the nation knew under him have flitted over the horizon. A powerful clique of army officers and aristocratic land-owners wants the monarchy restored, precisely as was the case in France in 1848.

Furthermore, it is constantly reported that the son of the ex-kaiser, the former Crown Prince William will seek the presidency of Germany shortly, with Von Hindenburg resigning to make way for him. William does not deny it. It is an open secret that the Junkers want him to. What would happen then? Restoration of the Hohenzollern monarchy, a fight to regain the lost place in the sun, a new war with France—the possibilities are ominous. We can only hope that in this instance history will not even come close to repeating itself.
