CONVICTIONS

Bearing out the contentions of a recent Public Forum regarding the unreliability of jury verdicts in cases involving prohibition law violations and drunken driving, is the case, which recently occurred in Portland.

A driver had piloted his automobile into another car severely injuring the driver of the other car. Four policemen testified in the case that the offending driver was in an extreme condition of intoxication. Several other witnesses confirmed the testimony of the policemen.

But the jury of two men and three women failed to reach an agreement on a verdict.
 Judge Stadler, before whom the case was tried, in dismissing the jurors, said:

"I don't know what we are coming to, of jurors cannot agree when the evidence is as strong as it was in this case, I guess we will have to allow drunken drivers to run rampant through our streets."

In testifying in the case a traffic officer swore that the condition of the man at the time of the wreck was one of the most flagrant he had ever seen. Three officers substantiated his testimony.

"Isn't a thing jury in such a case a breakdown of the law?" asks a coast newspaper, and continues: "Is it not perfectly apparent that some of the jurors were not guided by the evidence and the law? Though under oath to render their verdict according to the law and the facts, some of them must have been guided wholly by their own views or prejudices. 'No wonder the judge said 'I don't know what we are coming to.' The last stronghold of justice is the jury. The courts are the sanctuary of self-government. The jury system is the protection of the weak against the strong. It was the only safeguard of the injured driver against the intoxicated driver who crashed into his car."

If jurors disobey the law, ignore testimony and disregard the oath they take when sworn in as jurors, nobody knows "what we are coming to."

THE BONUS ARMY DISBANES

The dissolution of the Bonus Army Expeditionary Force at Washington seems to be in progress, and few Americans will regret it. But while the breaking-up of the embattled bonus marchers goes forward, it is worth while to toss a bouquet, and a good big one at that, to the Washington police force for its wise handling of a very difficult problem, as well as praise to the taxpayers for their admirable restraint.

The bonus marchers presented the police of the national capital with a ticklish situation. Here were several thousand men, all of them deeply disgruntled, practically all of them broke, all of them determined to impress their will on the national government. Radical elements were doing their best to stir up trouble. Had the police treated them with the hard-boiled attitude that police of certain other cities have displayed in the face of demonstrations by the unemployed, a disastrous clash would have been almost inevitable.

That such a clash never materialized speaks volumes for the intelligence and patience of the Washington police and the leadership of the mob.
