GENEVA, (UPI)—With withdrawal from Manchuria of all Japanese troops, the Lyttor commission's report, being studied today by League of Nations officials, has been condemned as "unjustified." It called for a strong international military committee in Manchuria and urged Japan to withdraw its troops after a strong autonomous government with an effective police force is established.

The League's commission appointed to gain an objective neutrality in Manchuria and to negotiate a peace agreement with Japan, failed to take seriously Japan's claim that the new state of Manchukuo must be recognized before China should curb its aggressive nationalism and end much of its autonomy.

Maintaining of the "open door" in Manchuria, a cardinal American policy, was condemned by the commission's main recent recommendations for peaceful settlement.
