NEW YORK, April 13 (AP)—Captain Eddie Rickenbacker, president of the Eastern Airlines, said today 52 of 240 maintenance employees of the line's New Jersey plant will remain on the job until next week, when they will be sent to Miami, Fla., and Atlanta, Ga., to help meet the demand for planes.

## KANSAS CITY'S MANAGER QUITS

Ponderost 'Alde' Resigns on  
Heads of Major Nar-  
cotic Roundup

KANSAS CITY, April 13 (AP)—White-haired Henry P. McElroy today quit as the city manager's post. He is 63 years old. He was appointed to the Democratic administration now under the withering fire of federal vice, fraud and graft directed at the city by U. S. Sen. Alf Landon.

Mayor Byers B. Smith announced the resignation, and it immediate acceptance. Smith earlier reached agreement with his successor on payment and proclaimed Kansas City "clean" after the mattock-sifted purging activities.

A resignation, written late yesterday, said simply:

"I hereby tender my resignation as city manager."

Smith had called a meeting of the city council for Saturday to select an acting manager. Mentioned prominently for the place was his 3-year-old secretary, Eugene Zahn.

McElroy, 70, has been in control of the city affairs since 1920 under the watchful eye of members, including the mayor.


"He has been persecuted,


